

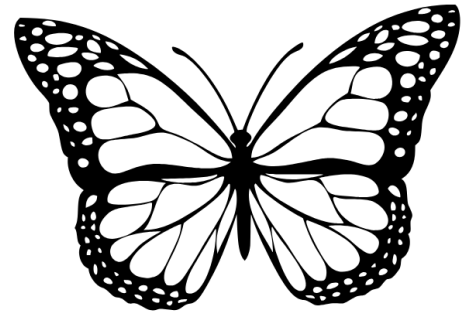
7 Ways to Take Action to #ShutDownDetention



Immigrant communities are under attack. The Trump administration has implemented horrendous immigration policies; closed the border, gutted asylum, ended most refugee programs and is expanding ICE enforcement, deportation, and detention. We are seeing first hand how these policies are violating people's rights both in our local communities. ICE continues to attack our friends, family, and neighbors through detention, surveillance and deportation, separating families and sending people back to the hostile conditions they fled, and in some cases countries they've never lived in. **That is why we call on the Clearfield County Commissioners to end the contracts at the Moshannon Detention Center, the largest immigrant prison in the northeast.** They have the power to end their contract with ICE and their contract with the GEO Group NOW.

Action #1: Make a Call (or three)

Action #2: Write a Letter or Send an Email

Write a letter, email or postcard to the Clearfield County Commissioners to tell them in your own words why you want them to Shut Down Moshannon and invest in real human services for the surrounding community. You can organize a letter writing party and spend time with friends while writing, or get a package of pre-stamped postcards and send one every time you read something about Moshannon or immigrant detention.

Action #3: Send a Video Message

Personalize your message via email even more, by taking one minute to record a video message to the Clearfield County Commissioners about why they should end the ICE contract and Shut Down Moshannon right now! Consider organizing a video making party with your friends and networks.

- Step 1: Take out your phone and put it on selfie mode
- Step 2: Record a short message of 30-60 seconds long. Consider using a Teleprompter app.

Sample script:

"As a resident of Pennsylvania, I believe in the right to freedom. As long as the Moshannon Detention Center remains open, due process rights remain on the line. Commissioner Tim Winters, John Sobel and Dave Glass, end the ICE contract today!"

Action #4: Volunteer a Saturday for Visitation Assistance



Often we hear that loved ones attempting to visit Moshannon are denied access. Frequently visitors are not told why they are rejected. Some are traveling several hours only to be sent away without explanation. One of the most common reasons cited is improper attire. You can help by:

- On Saturdays, we are setting up help stations in the lot with clothes, changing stations, and information for resources. Email joroberta24@gmail.com to gain access to the supplies and clothes.
- Donate! We are actively accepting donations for clothing to be handed out to those denied visitation. Ask us what type of attire we're currently accepting.

Action #5: Organize a Local Event-Occupy the Lot

Help spread the word by organizing a local event! Many organizations have partnered together to host demonstrations in the parking lot outside of the facility. All you need:

- Gather yourself and as many friends as possible.

- Protest to tell the town and GEO that you want the facility closed.

Action #6: Go to a Clearfield Commissioner Meeting

Go to a Commissioner meeting and tell them directly why you want them to end the contract.
